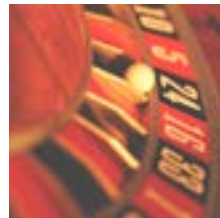

12 Regions



Each region has an active committee made up of volunteers from within the licensing profession.

Regional training days are held regularly and are often **free to members** or heavily subsidised by the regions and generally offer CPD accreditation.
